If you are wondering what fellow members of WLB are thinking, you can download the <u>results of our</u>

<u>Winter 15/16 EU referendum member survey</u>. The headline results: 55% stay in; 35% undecided and waiting for the Prime Minister to conclude his negotiations; and 10% leave. (The survey was conducted before the Prime Minister completed his negotiations.)

Over the next two months monitor our <u>Partner Events calendar</u> where we will signpost to **EU debates** taking place in West London where the case will be made by both sides. Cross Party Group for West London

On Wednesday 13 April a group of representatives of both houses of parliament convened at The Red Lion, Westminster to establish the Cross Party Group for West London. West London Business, supported by member company Fuller, Smith & Turner Plc, are providing the secretariat for the group. Lord Young of Norwood Green was appointed chair of the group, with Bob Blackman MP (Harrow East) and Seema Malhotra MP (Feltham & Heston) both appointed vice-chairs.

The group's purpose is "To provide a forum that brings parliamentarians together with key leaders in business to consider and discuss opportunities to maximise investment in the West London economic powerhouse."
